Featured Speakers

Deborah Jiang Stein's personal story finds triumph against great odds that began as a special needs and at-risk child: a heroin-exposed infant born in Alderson federal prison in WV. Deborah chronicles her challenges, from the stigma of prison and foster care, her journey in adoption, and all compounded with multi-racial identity. After a life of substance abuse and in the margins of life, she re-frames herself into the positive force she is today.

Dr. David Chaffin is a professor of obstetrics and gynecology and has been the head of the division of Maternal Fetal Medicine at the Joan C. Edwards School of Medicine at Marshall University since 1998. Following medical school at the Johns Hopkins University, he completed residency training at Vanderbilt University and specialty fellowship training at the University of Arizona. He has practiced maternal fetal medicine in West Virginia since 1998 and is interested in all aspects of prenatal care.

Chad Barker is the Chief Deputy Sheriff for the Boone County Sheriff's Department in Madison, WV. He has been a deputy for over ten years, has worked undercover drug cases for the last five years and has work or been involved in hundreds of drug investigations. He has an Associates Degree from Marshall University and is certified by WV LET to train police officers

Susan Webber-Brown Sue Webber-Brown is the Director of the California DEC Training and Advocacy Center. She is recently retired after 26 years with the Butte County District Attorney Office, 18 years as a detective in narcotics. Sue developed the first successful "Drug Endangered Children" (DEC) program of it's kind in the country. Sue has rescued over 2,000 children in her county, trained over 40,000 professionals in 32 states and was honored by President George W. Bush for her work with DEC.

Brandon Lewis is the program coordinator for the WV Clandestine Laboratory Remediation Program for the Bureau for Public Health.

Megan Wheeler is an independent training and technical assistance consultant in the justice, treatment and social services fields. Ms. Wheeler previously worked for the National Drug Court Institute (2001-2009); as the Project Director where she managed adult and family drug court training and technical assistance activities. Ms. Wheeler received her Master of Science degree in Administration of justice and Bachelor of Arts degree in psychology and criminal justice from Mercyhurst College, Erie, Pennsylvania
